



## Student Referral Rewards

### Terms and Conditions

The following terms and conditions apply to the Student Referral Reward (SRR) offered by  
Real Estate Training Academy

#### 1. ELIGIBILITY CRITERIA

Student Referral Rewards (SRR) is a program that offers a reward to current or past students (referrer/s) of Real Estate Training Academy for introducing new students to Real Estate Training Academy.

For a referrer to receive the Student Referral Reward, the student being introduced to Real Estate Training Academy must:

- 1.1. be a new enrolment in either
  - 1.1.1. **CPP40307 Certificate IV in Property Services (Real Estate)**, or
  - 1.1.2. **CPP50307 Diploma of Property Services (Agency Management)**, and
- 1.2. follow our enrolment process including meeting course entry requirements, and
- 1.3. pay the deposit in full required for the qualification, and
- 1.4. the student being introduced to Real Estate Training Academy must identify the referrer in their Enrolment Form at the time of enrolment.

The student being introduced to Real Estate Training Academy may nominate only one referrer.

#### 2. THE REFERRAL REWARD

- 2.1. The Student Referral Reward is one e-Gift voucher from Woolworths to the value of \$100. The e-Gift voucher will be emailed to the referrer using their email address on file. It is the referrers' responsibility to ensure we have their current email address for the delivery of the e-Gift voucher.

- 2.2. Each e-Gift is currently valued at \$100. Real Estate Training Academy reserves the right to change the type and value of the SRR at any time without notice.

### **3. OTHER CONDITIONS**

- 3.1. The referrer must be a natural person. If the referrer is a body corporate, then the body corporate must be a Registered Land Agent.
- 3.2. The referrer cannot be from any organisation that receives any Local, State or Commonwealth Government funding for training.
- 3.3. The SRR can only be claimed by currently enrolled or past students of the Real Estate Training Academy.
- 3.4. The SRR cannot be claimed if the student being introduced to Real Estate Training Academy was previously enrolled at Real Estate Training Academy.
- 3.5. The SRR only applies to the full qualifications referred to in 1.1.1 and 1.1.2 and does *not* apply to any other enrolment at Real Estate Training Academy.
- 3.6. The SRR does not apply to new enrolments that qualify for Credit Transfers or Recognition of Prior Learning.
- 3.7. In the interests of full disclosure, the person being introduced to Real Estate Training Academy will be advised that their referrer will receive an e-Gift from Real Estate Training Academy for having introduced that person to Real Estate Training Academy.
- 3.8. The SRR cannot be substituted for cash or applied towards payment of any course, training, service or product of Real Estate Training Academy.
- 3.9. Real Estate Training Academy, at its discretion, can pause, terminate and re-start the Student Referral Rewards initiative at any time and without notice.
- 3.10. Real Estate Training Academy reserves the right to review, amend or vary these terms and conditions at its discretion and without notice.
