- 1.2. Complete our enrolment process, including meeting course entry requirements, completing, and submitting an Enrolment Form, providing a copy of their photo ID and paying their deposit in full.
- 1.3. Identify the Referrer in their Enrolment Form at the time of enrolment.

2. The Referral Reward

- 2.1. One Student Referral Reward is one e-Gift voucher from Woolworths to the value of \$100. The e-Gift voucher will be emailed to the Referrer using their email address on file. It is the Referrer's responsibility to ensure we have their current email address for the delivery of the e-Gift voucher.

3. Conditions
